The above project provided for the reconstruction of the I-55/Gluckstadt Road Interchange. In addition to the replacement of the bridge on Gluckstadt Road over I-55, construction included the installation of an interchange lighting system.

The project has been completed and the contractor released from maintenance with the exception of the items associated with the establishment of specified vegetation growth and coverage.

This is our formal request that the County assume and "take-over" complete maintenance for the interchange lighting system as well as the cost of electrical service to light the system. This is in accordance with the Construction and Maintenance of High Mast Lighting System Agreement executed on May 17, 2011, between the Madison County Board of Supervisors and the Mississippi Transportation Commission.

FOR CONSTRUCTION AND MAINTENANCE OF
HIGH MAST LIGHTING SYSTEM AT THE
I-55 / GLUCKSTADT ROAD INTERCHANGE

This agreement, hereinafter referred to as "AGREEMENT" made and entered into by the Mississippi Transportation Commission, hereinafter referred to as the "COMMISSION," acting by and through the duly authorized Executive Director of the Mississippi Department of Transportation, and Madison County, Mississippi, hereinafter referred to as the "COUNTY," effective as of the date of the latest execution below.

WITNESSETH:

WHEREAS, the "COUNTY" desires that the interchange at the intersection of Interstate 55 and Gluckstadt Road be lighted by an Interchange lighting system, and

WHEREAS, the "COMMISSION" has determined that it is in the best interest of the traveling public that the said interchange be lighted by an Interchange lighting system, and

NOW THEREFORE, for and in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

I

The "COMMISSION" will let to contract Project No. NH-0055-02(205) / 103063, Madison County, hereinafter referred to as the "PROJECT," which will include the installation of the Interchange lighting system for said interchange. The lighting system is to be completed and in working order to comprise a fully operational unit to satisfactorily light the said

interchange to acceptable standards. The said cost of installation is to be paid by the "COMMISSION."

II

The "COUNTY," prior to the COMMISSION's advertisement of the contract described in Paragraph I above, will execute and spread upon the minutes of the Board of Supervisors, the "AGREEMENT," and will furnish a copy of said minutes to the "COMMISSION" for inclusion as an attachment to the "AGREEMENT." Upon completion of the "PROJECT" and upon written notification of completion by the "COMMISSION," the "COUNTY" will accept, assume, and "take-over" for complete maintenance the Interchange lighting system in said interchange, including any and all replacement parts, labor, equipment and maintenance to replace light bulbs, ballasts, fuses and plugs, and the cost of electrical service to light the system and all other incidentals necessary to maintain the system in a safe and satisfactory manner.

III

The "COMMISSION" does grant to the "COUNTY" an easement to, over and on the right-of-way necessary to reach the location of the Interchange lighting towers and the buried electrical cable to maintain same as required. All traffic control necessary to maintain the lighting system will be provided by the "COUNTY" in accordance with the most current version of the Manual on Uniform Traffic Control Devices (MUTCD).

IV

Either party hereto may terminate this "AGREEMENT" at will, by providing the other party written notification of termination prior to the COMMISSION's advertisement of the

"PROJECT" for construction. Said notification must be provided to the other party at the Notification Addresses appearing below at least thirty (30) days prior to the date of termination. Upon the COMMISSION's advertisement of the PROJECT for construction, this AGREEMENT may be only be terminated by mutual agreement of both parties. The term of this "AGREEMENT" is to begin on the latest date of signing below and to continue until terminated as provided above. Upon termination of this "AGREEMENT, subsequent to the installation and completion of the Interchange lighting system, the lighting system will be removed by the "COMMISSION" and the "COUNTY" will reimburse the "COMMISSION" for the cost of removal. The lighting equipment will remain the property of the "COMMISSION."

V

VI

GENERAL PROVISIONS:

AMENDMENT - This "AGREEMENT" may be amended in writing as mutually agreed upon by the parties in writing.

SEVERABILITY - Should any provision of this "AGREEMENT" be found to be unconstitutional, or otherwise be contrary to the laws of the State of Mississippi or the United States of America, to the extent that it is reasonably possible to do so, the remainder of this "AGREEMENT" shall remain in full force and effect.


THIRD PARTY BENEFICIARY - It is not intended by any of the provisions of this contract to create in the public or any member thereof as a third party beneficiary or to authorize any one not a party to this contract to maintain a suit for personal injury, contractual damage or property damage pursuant to the provisions of this contract. The duties, obligations, and responsibilities of the parties to this contract with respect to third parties shall remain as imposed by law.

LEGAL RESPONSIBILITY - Unless specifically agreed to elsewhere, the parties hereto agree that the "COMMISSION" has no authority to select, supervise, or compensate any contractor or employee engaged by the "COUNTY" to perform the above described maintenance, and the "COUNTY" takes full responsibility for those functions. No employee, agent, or contractor of the "COUNTY" will, under the provisions of this "AGREEMENT," be entitled to any right or benefit accorded to any contractor, agent, or employee of the "COMMISSION" or the Mississippi Department of Transportation.

IN WITNESS WHEREOF, the "COMMISSION" and the "COUNTY" each binds itself, or its successors, and assigns to the other party of this "AGREEMENT," and to the successors and assigns of each party in respect of all covenants of this "AGREEMENT."




