
Subject: Authority to purchase furniture for office to be used by County Judge-Elect Staci ONeal

Dear Board Members:

Per Mississippi law furniture purchases for circuit, chancery, and county courts greater than \$500 in any one year require prior board approval.

County Judge-Elect Staci ONeal has requested new furniture for the office that she will occupy effective January 3, 2016. The outgoing county judge personally owned all of the furniture that was in the office except for an older desk that would be almost impossible to match to a new credenza and hutch. Per the attached quote a new desk, credenza and hutch in the Balmoor line requested by Judge-Elect ONeal would cost \$4,564.

TITLE 9. COURTS  
CHAPTER 1. PROVISIONS COMMON TO COURTS  
GENERAL PROVISIONS

Miss. Code Ann. § 9-1-37 (2016)

§ 9-1-37. Allowance for stationery

The circuit, chancery and county courts shall make allowance to the clerks thereof of all needful sums for supplying the offices and courtrooms with necessary stationery, **furniture**, books, presses, seals, and other things necessary for the same, and for the safe-keeping of the books, records, and papers belonging thereto; and such allowance shall be certified to the board of supervisors. Provided, however, that **in no event shall said circuit, chancery or county courts be allowed to purchase furniture in excess of five hundred dollars for any one year without first securing the approval of the board of supervisors of the county.**
