- The Board directed the County Administrator to pursue the purchase of 2 lots near the current tax building in the City of Madison.
- The Board voted to approve a resolution requesting the legislature raise the statutory cap on the amount of funds which the County may borrow on behalf of the Madison County Economic Development Authority (MCEDA) from \$12 million to \$25 million.
- The Board approved an engagement letter to issue 2 series of bonds totaling up to \$55 million. Up to \$20 million will be designated for the acquisition of real property to be used in economic development through MCEDA. The remaining \$35 million is to be spent on the Madison County Capacity Improvement Plan. A map of the Capacity Improvement Plan is available here.
- The Board approved purchasing ten laptops for the Canton Police Department through the County's E-911 funds.
- The Board approved the final plat of Warren Meadows. The development is 6 lots on approximately 39.99 acres.
- The Board approved the final plat of Scott Farms. The development is 12 lots on approximately 193.09 acres.
- The Board approved the final plat of The Meadows at Stout Farms, Part 4. The development is 11 lots on approximately 62.21 acres.
